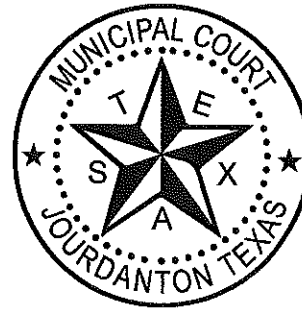

PLEASE READ BEFORE CALLING

- 1. This letter is furnished as a courtesy to you by the Jourdanon Municipal Court to assist you in making a disposition of the charges filed against you.
2. IF YOU WISH TO ENTER A PLEA OF GUILTY OR NOLO CONTENDERE, please indicate below in the proper space provided and remit the fine by Money Order or Cashier's Check, in person or by US MAIL on or before the appearance date on your ticket.
3. The fine for a NOLO CONTENDERE plea is the same as that of a PLEA OF GUILTY.
4. You must refer to the schedule of acceptable fines (Page 3) to determine the total amount of your fine(s) and costs assessed against you.
5. IF YOU WISH TO ENTER PLEA OF NOT GUILTY and desire a trial, you must indicate in the proper space provided below.
6. YOU HAVE THE RIGHT TO REQUEST A DRIVING SAFETY COURSE, approved under the Texas Driver and Traffic Safety Education Act (Article 4413(29c), Vernon's Texas Civil Statutes only if you have not completed a course in the past 12 months prior to this citation.
7. You have exactly 90 days from the issuance of citation to take a driving safety course and submit the certificate of completion (court copy) to the court, NO EXCEPTIONS.
8. EFFECTIVE SEPTEMBER 1, 2002 CDL drivers are NO LONGER ELIGIBLE for Driving Safety Course.
9. If you receive a citation for NO LIABILITY INSURANCE, proof must be shown with the effective date prior to the issuance of the citation and show proof to the Court prior to your appearance date, your case will be dismissed.
10. Charges for Expired Motor Vehicle Registration, Driver's License and Failure to Change Name/ Address if Remedied with 20 Working Days of date of citation or due date, will be dismissed with a \$20.00 (money order or cashier's check only) dismissal fee plus a copy of the receipt upon proof of renewal.
11. Charges for Failure To Show License on Demand, if presented within 10 Working Days of date of citation will be dismissed with a \$10.00 (money order or cashier's check only) dismissal fee.
12. IF YOU FAIL TO RESPOND TO THIS CHARGE BY THE APPEARANCE DATE ON THE CITATION, AN ADDITIONAL CHARGE WILL BE FILED AGAINST YOU FOR FAILURE TO APPEAR AND A WARRANT OR WARRANTS WILL BE ISSUED FOR YOUR ARREST.
13. Make your remittance by Cashier's Check or Money Order made payable to the Jourdanon Municipal Court. Return a copy of the citation and this letter with your remittance to assure proper credit to the Jourdanon Municipal Court indicated on your citation, To get a receipt send a self-addressed stamped envelope.

AFFIDAVIT AND REQUEST TO TAKE DRIVING SAFETY COURSE

The above named defendant, having been duly sworn upon oath states the following:

- 1. I have not completed nor am I currently taking or approved to take a Driving Safety Course (under VSC Art.6701d Sec. 143A (a) for traffic citations issued within one year of the date of the citation and that is not reflected on my driving record.
2. I do have a TEXAS DRIVER'S LICENSE / PERMIT AT TIME OF CITATION OR ACTIVE U.S. MILITARY I.D. AND SPOUSE OR DEPENDANT OF.
3. I have a vehicle insurance policy, a certificate of self-insurance or a financial responsibility certificate. IMPORTANT NOTE: Your request for Defensive Driving will be denied, unless you submit proof that you are INSURED as required by law. THE PROOF MUST BE ATTACHED TO THIS AFFIDAVIT. PHOTOCOPIES ONLY. ORIGINALS WILL NOT BE RETURNED.
4. I will provide a certified copy of my five (5) year driving record from the Texas Department of Public Safety before I take the course. Once the Court receives your request for the driving safety course, an application for your driving record will be mailed to you courtesy of the Court. (512) 424-2600. www.txdps.state.tx.us/driverlicense/

Based upon the foregoing, I hereby waive trial by jury, enter a plea of No Contest and request that the Court defer proceedings for 90 days so that I may complete an approved Driving Safety Course. I understand that I MUST COMPLETE and RETURN an ORIGINAL COURT CERTIFICATE showing that I have completed a Driving Safety Course which is approved by the Texas Driver and Traffic Safety Education Act (Article 4413(29)c, Vernon's Texas Civil Statutes) to the Court no later than 90 days from the date the citation was issued to me.
