Any disruptive behavior, including shouting or derogatory statements or comments, will be ruled out of order by the Presiding Officer. Continuation of this type of behavior could result in a request by the Presiding Officer that the individual leave the meeting, and if refused, an order of removal. (Ordinance #505)

The Mayor reserves the right to change the order of items on the agenda in his/her discretion and in the interest of the public concern.

WELCOME AND CALL TO ORDER (Mayor Robert Williams)

- 1.1 The City Council, City Manager and Consultants will visit with City Manager candidates during a breakfast.

HEARING OF RESIDENTS

City Council may present any factual response to items brought up by citizens. (Attorney General Opinion – JC-0169) (Limit of three minutes each). The City Council welcomes citizen participation and comments at all regular council meetings. As a courtesy to your fellow citizens and out of respect to our elected officials, we request that if you wish to speak that you follow these guidelines. Failure to follow these guidelines may result in a forfeiture of your remaining time to speak and removal from the meeting:

- (a) Limit your discussion to one or two issues that you wish to address rather than a generalized statement; and
- (b) Show the City Council the same respect and courtesy that you expect to be shown to you.

EXECUTIVE SESSION


- 2.1 City Council shall convene into executive session for the following purposes:
- a. Interviews for City Manager will be conducted by Jourdanton City Council.
 - b. Pursuant to Texas Government Code, Section 551.074 (entitled “Personnel Matters”) City Council shall deliberate the appointment, employment, evaluation, of a new City Manager. (Mayor Robert Williams)
- 2.2 Reconvene in Open Session. At the conclusion of the closed session, City Council shall reconvene in open session and may take action on any matter lawfully discussed in closed session. Such action may include the appointment of a City Manager and approval of a contract.
