**HEARING OF RESIDENTS**

City Council may present any factual response to items brought up by citizens. (Attorney General Opinion – JC-0169) (Limit of three minutes each). The City Council welcomes citizen participation and comments at all regular council meetings. As a courtesy to your fellow citizens and out of respect to our elected officials, we request that if you wish to speak that you follow these guidelines. Failure to follow these guidelines may result in a forfeiture of your remaining time to speak and removal from the meeting:

- (a) Limit your discussion to one or two issues that you wish to address rather than a generalized statement; and
- (b) Show the City Council the same respect and courtesy that you expect to be shown to you.

- 2.1 Discussion and possible action to approve an employment agreement with Bobby Martinez to serve as Jourdanton City Manager; Introduction of Mr. Martinez to the Community (Mayor Robert Williams)
- 2.2 Introduction of Vanessa Alvarado as the new Finance Director. (City Manager Lamar Schulz)
- 2.3 Discussion and possible action to add a JVFD vehicle to the City Insurance Coverage. (City Manager Lamar Schulz)
- 2.4 Discussion and possible action to direct staff and the City Attorney to draft a Fire Services Agreement with the Jourdanton Volunteer Fire Department (JVFD). (City Manager Lamar Schulz and JVFD representative)
- 2.5 Discussion and possible action to allow a one-time exception to Article 5, Section 5.01 (c) of the City of Jourdanton Personnel Policy to allow a City employee, to sell back 73.98 earned vacation hours to the City for a total of \$1,667.51.


